#### **ORDINANCE NO. 2017-05**

AN ORDINANCE OF THE TOWN OF QUINTANA, TEXAS, MAKING CERTAIN FINDING OF FACT REGARDING THE FILING OF AN ACTUAL PROPOSED BUDGET FOR SAID TOWN BY THE MAYOR THEREOF; ADOPTING A BUDGET FOR SAID TOWN FOR THE FISCAL YEAR OCTOBER 1, 2017 THROUGH SEPTEMBER 30, 2018.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF QUINTANA, TEXAS;

#### <u>SECTION ONE - PRESENTATION OF BUDGET</u>

The Town Council of the Town of Quintana, Texas, finds as a matter of fact:

- a. That the compliance with the provisions of Local Government Code 102, the Honorable Steve Alongis, Mayor of said Town, prepared the proposed actual budget for the fiscal year **beginning October 1, 2017 and ending September 30, 2018**, for said Town, a true and correct copy of which is attached hereto as Exhibit "A" and which is incorporated herein by reference.
- b. That heretofore, in compliance with said statutes, the Mayor filed the same with the Secretary of said Town.
- c. That, in compliance with the Local Government Code 102, public notice of, time and place of the hearing to be conducted thereon by the Town Council was given.
- d. That, this action of being taken after the public hearing held on said budget in compliance with Local Government Code 102.
- e. That, all legal requirements for the adoption of this budget have been met.

### SECTION TWO - ADOPTION OF FY 2017-2018 ACTUAL BUDGET

The Town Council of the Town of Quintana, Texas, pursuant to the provisions of said Local Government Code 102, does hereby adopt said budget for said Town for the fiscal year which begins October 1, 2017 and which ends September 30, 2018, except for any changes therein reflected, which the said Town Council, in their judgment hereby finds that the law warrants and the best interest of the taxpayers of said Town demand, said budget, as changed, being said Exhibit "A" known as the Approved Budget, attached hereto and made a part hereof, and which is incorporated here by reference.

#### SECTION THREE - EXPENDITURES

The Town Council of the Town of Quintana, Texas, hereby authorizes and prescribes the following method of contracting and paying for the items of expense contained in the budget of said Town of the fiscal year 2017-2018:

#### a. By Mayor or Mayor Pro Tem:

The Mayor, Mayor Pro Tem or City Administrator of said Town are hereby authorized to contract for the purchase and to issue checks on the funds of said town, not exceeding a total amount budgeted, in payment of any item of expense authorized by such budget without further authority from the Town Council of said Town where the amount to be expended in any one instance is less than One Thousand Five Hundred Dollars (\$1,500.00).

### b. Expenses of One Thousand Five Hundred Dollars (\$1,500.00) or over:

The Mayor, Mayor Pro Tem or City Administrator of the Town of Quintana, shall be authorized to contract for the purchase and to issue checks on the funds of said Town, not exceeding the total amount of the funds budgeted, in payment of any item of expense authorized by the budget, where the amount to be expended in any one instance is One Thousand Five Hundred Dollars (\$1,500.00), after a favorable vote of the majority of the Council present and voting at a regular or special meeting of the Town Council of said Town, the results of which are entered upon the minutes of such meeting.

#### **SECTION FOUR - SEVERANCE CLAUSE:**

In the event any section or provision of the Ordinance is found to be unconstitutional, void or inoperative by the final judgment of the court competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

### <u>SECTION SIX - EFFECTIVE DATE OF THIS ORDINANCE:</u>

This Ordinance shall be effective immediately upon its passage and approval.
