ORDINANCE 2014-04

AN ORDINANCE OF THE TOWN OF QUINTANA, TEXAS, MAKING CERTAIN FINDINGS OF FACT REGARDING AND CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE ANNUAL GENERAL ELECTION AND SPECIAL ELECTION HELD IN AND THROUGHOUT SAID TOWN, ON THE 10TH DAY OF MAY, 2014 A.D. FOR THE PURPOSE OF ELECTING THREE COUNCIL MEMBERS BEING COUNCIL POSITION NUMBER 3, COUNCIL POSITION NUMBER 4, AND COUNCIL POSITION 5; PROVIDING FOR RATIFICATION AND CONFIRMATION OF THE ACTION TAKEN BY THIS ORDINANCE BY THE MAYOR OF SAID TOWN; PROVIDING AN EFFECTIVE DATE FOR THIS ORDINANCE; AND PROVIDING A METHOD OF PUBLICATION.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF QUINTANA, TEXAS:

Section I - Scope of Ordinance:

This ordinance relates to the Annual General Election called by Ordinance 2014-01 (the "General Election") of the Town of Quintana, Brazoria, County, Texas, which were read, passed, approved and ratified on the 10th day of February, 2014 A.D., by the Town Council and Mayor of said Town, ordaining and ordering respectively, that such Elections be held in and through the said Town on the second (2nd) Saturday in May, 2014, to wit: the 10th day of May, 2014 for the purpose of electing three (3) Council Members, each to serve two (2) year terms.

Section II - Finding of Fact Regarding Election:

The Mayor and Town Council of the Town of Quintana, Texas, make the following findings of fact with respect to the said Elections, to-wit:

FIRST, that notices of said Elections were given in the manner and at the time required by law;

SECOND, that said General Election was duly called and held in the manner and at the time required by law pursuant to said Ordinance Number 2014-01, and that only qualified voters were permitted to vote in such election;

THIRD, that based on the returns of said Elections, which are now before the Mayor and Town Council, and which are found to be in due form and order and to have been regularly made as required by law, a total of 39 votes were cast at said Annual General Election; and

FOURTH, that the following named persons received the number of votes set opposite their names to wit:

Section III - Declaring the Results of The Election

The Mayor and the Town Council of the Town of Quintana, Texas, hereby declare and ordain, respectively, that **KATHRYN WILSON** has been elected to the Council position Number 3, **LINDA MARTIN** has been elected as Council Position Number 4 and **DEBBIE ALONGIS** has been elected to the Council position Number 5. Each person shall be entitled to said office upon taking the Constitutional Oath of Office as required by law, for such term and until his/her successor shall have been duly elected and qualified according to law.

Section IV - Ratification and Confirmation of Mayor

By signing this ordinance, the undersigned Mayor of the Town of Quintana, Texas, hereby ratifies and confirms as his action all matters hereinabove recited, which by law come within his jurisdiction.

Section V - Effective Date

This ordinance shall be effective immediately upon its passage and approval.
