

ORDINANCE NO. 2017-03

AN ORDINANCE OF THE TOWN OF QUINTANA, TEXAS; DECLARING THE UNOPPOSED CANDIDATES FOR MAYOR AND COUNCIL POSITION NOS. 1 AND 2 ELECTED; PROVIDING THAT THE MAY 6, 2017, GENERAL MUNICIPAL OFFICERS ELECTION SHALL NOT BE HELD; CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT; PROVIDING FOR SEVERABILITY; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF QUINTANA, TEXAS:

**Section 1.** The City Council of the Town of Quintana, Texas (the "City"), passed and approved Ordinance No. 2017-01 on January 17, 2017, for the purpose of electing three (3) officials of the City, to wit: Mayor and Council Position No. 1, and Council Position No. 2.

**Section 2.** Pursuant to said Ordinance No. 2017-01 and Section 143.007 of the TEXAS ELECTION CODE, the deadline for filing applications for a place on the ballot of the City's municipal officers election has expired and the deadline for filing as a write-in candidate has also expired.

**Section 3.** The City Secretary, in accordance with Section 2.052, TEXAS ELECTION CODE, has certified to the City Council in writing that **STEPHEN ALONGIS** is unopposed for election to the office of Mayor, **MIKE CASSATA** is unopposed for election to the office of Council Position No. 1 and **SHARI WRIGHT** is unopposed for election to the office of Council Position No. 2.

**Section 4.** The City Council hereby finds and determines that each candidate whose name is to appear on the ballot in said election is unopposed, and no proposition is to appear on the ballot for such election.

**Section 5.** In accordance with Section 2.053(a), TEXAS ELECTION CODE, the following unopposed candidates are hereby declared duly elected to the respective offices shown:

Mayor	-	Stephen Alongis
Council Position No. 1	-	Mike Cassata
Council Position No. 2	-	Shari Wright

**Section 6.** Pursuant to Section 2.053(b), TEXAS ELECTION CODE, the general municipal officers election heretofore called and ordered by Town of Quintana, Texas, Ordinance No. 2017-01 for the 6<sup>th</sup> day of May, 2017, shall not be held and is hereby cancelled.

**Section 7.** The City Secretary is hereby directed to cause a copy of this Ordinance to be posted on election day, same being May 6, 2017, at the polling place that would have been used in such election.


**Section 8.** In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the Town of Quintana, Texas declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

**Section 9.** All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.
